Terms and conditions

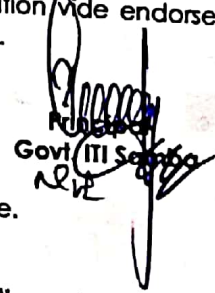
1. The guest Faculty/Teacher shall be paid remuneration as per applicable norms of the IMC guidelines
